further notice. All hearings, jury trials, and jury selection proceedings are postponed until further notice.

Any court filings due while the court is closed after 11:00 a.m. Friday, February 22, 2019 shall be deemed timely filed if filed when the court opens for regular business. Additionally, Chief Deputy Clerk Charles White will be available for immediate assistance with court emergencies at 988-9031. Electronic filing, as always, will be available to registered users throughout the day.

RELATIVE TO COURT CLOSURE DUE TO TYPHOON WUTIP Supreme Court of Guam Administrative Order No. ADM19-002

WHEREAS, on February 21, 2019, *I Åkto Maga'låhen Guahån*, issued a statement ordering non-emergency Government of Guam services to end at 1:00 p.m. on Friday, February 22, 2019, in anticipation of Typhoon Wutip. *I Åkto Maga'låhen Guahån* will declare Condition of Readiness (COR) 2 at 4:00 p.m. on February 22, 2019, in anticipation of Typhoon Wutip closing all executive branch departments and agencies of the Government of Guam until further notice; and

WHEREAS, due to Typhoon Wutip and in the interest of providing uniformity throughout the Government of Guam, it is reasonable likewise to close the Judicial Branch for public services beginning at 1:00 pm on February 22, 2019 and release all non-essential employees and upon the declaration of COR 2 by *I Åkto Maga'låhen Guahån*, the Judicial Branch will be closed until further notice:

**NOW, THEREFORE**, by the authority vested in me by the Organic Act of Guam, as amended, I do ORDER that, because *I Åkto Maga'låhen Guahån* has ordered that public services end at 1:00 pm today and will also declare Guam in COR 2 at 4:00 pm on February 22, 2019, the Judicial Branch of the government of Guam shall be closed for business at 1:00 p.m. until further notice.

IT IS FURTHER ORDERED that all hearings, jury trials, and jury selection proceedings scheduled for February 22, 2019 after 1:00 p.m. and any day after this date be rescheduled. Magistrate hearings will be held at the earliest opportunity following the declaration of COR 4 by *I Åkto Maga'låhen Guahån*. Any court filing due while the court is closed shall be deemed timely filed if filed when the court opens for regular business.
