GETTING GUAM'S TALENT BACK TO WORK



Lieutenant Governor Joshua F. Tenorio, Presiding Judge Alberto C. Lamorena III and Senator Mary Camacho Torres will jointly present on Getting Guam's Talent Back to Work. The key to reducing recidivism and improving public safety is finding employment for people. If individuals with a criminal record can be considered for employment based on their talent and skills, the benefits for the business community are far-reaching. Legislation such as the Fair Chances Hiring Process Act and the Judiciary of Guam's Adult Reentry Court Program are initiatives in the right direction to assist those with criminal records and the formerly incarcerated obtain gainful employment. Our panel will discuss how we as a community can do more to give opportunities to qualified people with a criminal background, deserving a second change.



ENGAGEMENT, MANAGING HR RISKS & RESPONSING TO COMPLAINTS
