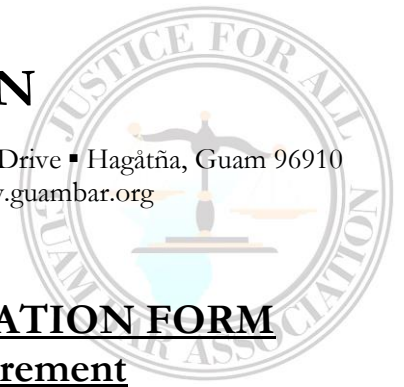

JOINT SUPREME COURT/GBA CLE CERTIFICATION FORM **Certification of Attendance: 2018 CLE Requirement**

FAILURE TO CURE A DEFAULT MAY RESULT IN ADMINISTRATIVE SUSPENSION

This form may be used to certify your 2018 CLE hours, or a separate certification may be submitted. The deadline is January 31, 2019. To use this form to certify your 2018 CLE hours, please follow these instructions.

The Supreme Court of Guam's CLE Rule requires that each active member of the GBA who is not exempt from the CLE requirement complete at least ten (10) CLE hours each calendar year, at least two (2) of which must be in the areas of professional responsibility and/or ethics. Further, on or before January 31, 2019, each member **must certify (INCLUDING A DESCRIPTION OF THE CLE HOURS COMPLETED) that they satisfied the CLE requirement by completing the mandatory CLE hours DURING THE 2018 CALENDAR YEAR.** To complete one's certification, supporting documentation must be submitted to both the GBA (284 West Chalan Santo Papa, Hagåtña, Guam 96910), and Supreme Court of Guam describing, in summary, how their CLE hours were earned. **CLE forms from the events attended may be submitted, or the standard GBA CLE reporting form may be used regarding each separate event. (The standard form can be found at www.guambar.org.)**

NOTE: Section 4(a) of the CLE Rule states as follows: "No member may submit a Certification of Attendance after January 31 without approval of the Supreme Court of Guam upon written request by the member." If you miss the January 31 deadline, the GBA Office is not authorized to accept untimely certifications.
