(Registration statements and/or payments sent by mail must be postmarked on or before January 1, 2019.) * **NOTE: This Entire Form Must Be Completed Each Year by All GBA Members,** regardless of whether the information may already be on record with the Bar. Further, Rule 5 of the Supreme Court of Guam's Rules for the Discipline of Attorneys requires that if any of your contact information changes during the registration year notice must be provided within thirty (30) days of such change. (A form for this notice can be found on the Bar website.) Failure to abide by this requirement can result in summary suspension barring an attorney from practicing law in Guam.

Members of the GBA that stop practicing law on Guam are required to keep the GBA informed of their current contact information for 10 years pursuant to Rule 5 of the Supreme Court of Guam's Rules for the Discipline of Attorneys even if they leave the GBA entirely.
